Minutes of the Meeting in connection with the procurement of Zoo Feed for animals of Manipr Zoological Garden, Manipur held on 3rd July, 2020 at 11:00 AM and chaired by the Additional Chief Secretary (For & Envt), Government of Manipur at his Office Chamber.

At the outset, the Additional Chief Secretary/Forest & Envt., Govt. of Manipur welcomed the Members present.

It was placed before the Committee that the earlier Tender was held in 2017 wherein agreement was signed between Director MZG and the Suppliers and that the validity of the Tender was only 2 (two) years (till December, 2019). The proposal for extension of validity for 3 (three) months i.e. from January, 2020 to March, 2020 has been sent to Finance Department consideration. Tender Notice for 2019 has already been published through DIPR in December, 2019 and Administrative Approval has also been obtained for the Tender Opening Committee (TOC) for 2 (two) years w.e.f. 1st April, 2020. And that the present DTC Meeting is being held as mandated by the financial procedures.

- 2. In connection with the above, it has been decided to procure Group I, II, III & IV feeds for the animals of MZG. Accordingly, Open Tender was floated and Notice inviting Tender of Bids was published in local dailies viz, Sangai Express (English), Hueyen Lanpao, Ichel Express and Ireibak on 25th December, 2019. Thereafter, Tender Opening Committee (TOC) was constituted to open tender at the o/o CCF/Wildlife on 16.01.2020. The TOC submitted the proceedings of the meeting and group-wise comparative statement of rates quoted by 4 (four) firms, viz M/s IK Soibam, M/s Maibia, M/s Bashi and M/s Dhurv. The comparative statements of bids submitted have been annexed.
- 3. The Tender Committee examined the quotations. Out of the four bids submitted, it was found that the price quoted by M/S Vashi is the lowest for Group-I @ Rs. 299/- per kg and for Group-II @ Rs. 750 per kg. And the price quoted by M/S Dhurv is the lowest for Group-III @ Rs. 712/- per kg and for Group-IV @ Rs. 705 per kg.
- 4. After taking into consideration the above facts, the Departmental Tender Committee recommended the procurement of Group I & II from M/S Vashi and Group III & IV from M/S Dhurv at a total amount of Rs. 94,00,000/- (Rupees Ninety Four Lakh only).
