Intending bidders should deposit a sum of Rs. 200/- in the form of D-at Call for the whole lot drawn in favour of Divisional Forest Officer, Central Forest Division, Manipur from SBI or any other Schedule Bank or by depositing in cash to the office of the Divisional Forest Officer, Central Fores t Division (if the above facilities are unavailable due to COVID-19) as earnest money deposit for joining the e-auction sale.
