No. 6/8/2016-17/DFO/C (Auction):- It is hereby notified for information of HPC Cleared Wood Based Units situated within the Minor Industrial Estates and the general public that e-auction sale of windblown Pine logs (A-2 Class) containing 15.874 cft dumped at Range Office Complex, Nongmaiching Range, Irilbung shall be held from 5.00 am of 11/9/2020 to 12.00 midnight of 12/9/2020 under the following terms and conditions:-

- Any individuals/registered qualified Forest Contractors/HPC cleared saw mills may join the e-auction sale.
- The e-auction sale will be held from 5.00 am of 11/9/2020 to 12.00 midnight of 12/9/2020 through the Online Portal of Forest Department, Manipur.
- The Pine logs will be sold in whole lots as mentioned above.
- Intending bidders may inspect the timber/logs lying at Range Office Complex, Nongmaiching Range, Irilbung and satisfy themselves of the quality and quantity of the timber before joining the e-auction. No complain about the quality and quantity of the timber after the e-auction sale bid will be entertained.
- Intending bidders should deposit a sum of Rs. 200/- in the form of D-at Call for the whole lot drawn in favour of Divisional Forest Officer, Central Forest Division, Manipur from SBI or any other Schedule Bank or by depositing in cash to the office of the Divisional Forest Officer, Central Forest Division (if the above facilities are unavailable due to COVID-19) as earnest money deposit for joining the e-auction sale.
- Sawing of the purchased timber is allowed only at authorised saw mills cleared by the HPC.
- The earnest money deposited shall be refunded after finalization of the e-auction sale. For successful bidder, the amount will be adjusted towards the amount to be paid by them.
- Amount once bided cannot be withdrawn. In case of withdrawal, the earnest money deposited will be forfeited.
