**OFFICE MEMORANDUM**  
Imphal, the 8<sup>th</sup> October, 2020.

**Sub: Online deposition of Forest Revenue in the Pooling Bank Account namely, “Online deposition of Forest Revenue” –reg.**

The undersigned is directed to inform that a new Current Account in the name of **“Online deposition of Forest Revenue”** has been opened as per the approval conveyed vide letter no. 20/75/2017-For. & Env't./339 dated 26-06-2020 from the Secretariat: Forests & Environment Department, Government of Manipur to enable the Online Portal and Forest website users to deposit the royalty and other revenues online to the Government of Manipur. Further, the process of developing the Online Payment Gateway with State Bank of India has also been initiated for online deposition of forest revenue.

2. In the meantime, the undersigned is further directed that the revenue shall be deposited online through RTGS/ NEFT/ Internet Banking or direct deposits by the consignees/ customers in the above mentioned bank account until the Payment Gateway is functional. The bank details are as under:

3. This Bank details may be shared with all Range, Beat offices and customers/ consignees seeking Transit Passes, licence, etc.


4. **“Payment Clearance”** shall be made on the basis of the uploaded deposit slips, online transaction copy, UTR no. copy, etc. In case of such online transaction and direct depositions in the Account, no TR-5 shall be used. The Wood Based Industries, Saw mills, contractors, etc. shall be encouraged to use the online deposition mode. TR-5 may be considered only in case of bonafide villagers.



4. As per directions of the Finance Department, Government of Manipur, **after every 2 (two) weeks, the concerned DFOs and CFs shall submit the separate figures of total revenue and GST deposits in the said account to the Nodal Officer (IT)/ Asstt. Nodal Officer (IT) without fail indicating the following Head of Accounts:**
