**AUCTION ORDER**Chandel, the 7<sup>th</sup> November 2020

In pursuance of letter no.8/23/2020/Forests dated 6<sup>th</sup> November 2020, It is hereby notified for information to all the registered Forest Contractor/HPC cleared Wood Based Units situated within the Minor Industrial Estate, general public and individuals that 125 Nos of standing trees of different species and sizes growing within the right of way along Pallel-Chandel section shall be sold by way of e-auction.

1. Any Registered Forest Contractors/HPC cleared Saw Mill located within approved MIEs/Wood based Units/individuals may join the e-auction sale.
2. The intending bidders may register at the Forest Department portal <https://forest.manipurforest.gov.in/tenders> for participating in the auction sale and bid till 5.00 pm of 16.11.2020. **No other means of bidding will be allowed except online.**
3. The intending bidders may inspect the trees and get themselves satisfied of the quality and quantity of the standing trees before joining the auction. NO complaint on the quality and quantity of the trees after finalization of the auction sale shall be entertained. Details of trees including species and size can be seen from the notice board.
4. The intending bidders shall deposit Earnest Money @5% of the value of the floor price of the trees growing along the section of roads they are interested to bid in the form of D-at-Call/Bankers cheque from any Scheduled Bank Drawn in favour of DFO/Chandel Forest Division, Manipur or in cash to the O/o DFO, Chandel (If the above facilities are not available due to COVID-19) for joining the e-auctions sale.
5. The Earnest Money deposited shall be refunded after finalization of the auction sale or may be forfeited to the Government if the terms and conditions of the auction sale are violated.
6. Amount once bided cannot be withdrawn. In case of withdrawal, the Earnest Money Deposited will be forfeited to the government.
7. Trees shall be felled after the felling permission is issued by the Divisional Forest Officer, Chandel Forest Division, Chandel by the successful bidder(s) on their own cost (including loading and transportation) under the supervisor of officials of the Chandel Forest Range.
8. The timber shall be for consumption within the State of Manipur only and no permit for transportation of the timber in log form outside the State shall be granted. The bidder shall apply for Transit pass for the auctioned quantity before movement.



9. The successful bidders shall deposit the bid amount along with GST to the Division Office within 3 (three) days of the approval of rate by the competent authority, failing which, the EM will be forfeited to the Government, and e-auction will be disposed of in the favor of second highest bidder.

10. The Divisional Forest Officer, Chandel Forest Division, Chandel reserves the rights not to accept or reject any tender/bid without assigning any reason thereof.

11. Acceptance of the bid amount will be subject to the approval of the appropriate authority of the Forest Department, Manipur.

12. In case of any dispute, the decision of the Principal Chief Conservator of Forests & HoFF, Government of Manipur shall be final and binding to all the parties.


