

In accordance to the powers conferred u/s 56 of the Indian Forest Act, 1927, the following seized/confiscated forest produces (uploaded for auction vide order of even no. dated 14th December, 2020 with no bidder), which are government properties, shall be sold by way of public auction through online bidding process till midnight of 10th January, 2021 (Sunday):



- Only HPC Approved Saw Mills located within approved MIEs/Wood based Units are eligible to bid in the Auction.
- The Forest produces will be sold in as-is-where-is basis. Interested individuals/ parties can check the quality and quantity during office hours. No complaints will be entertained once Bid is awarded after the cut-off date.
- The intending bidders shall deposit Earnest Money @5% of the value of the floor price of the forest produce to bid in the form of D-at-Call/Bankers cheque from any Scheduled Bank Drawn in favour of DFO/Chandel Forest Division, Manipur. The Earnest Money deposited shall be refunded after finalization of the auction sale or may be forfeited to the Government if the terms and conditions of the auction sale are violated.
- Only online bidding is allowed vis <https://forest.manipurforest.gov.in/tenders> and **No other means of bidding will be allowed except online.** No more advertisement will be made on this auction in the newspaper.
- The successful bidder should deposit the bid amount along with 18% GST to the Division Office within 3 (three) days of the final approval of rate by the competent authority, failing which, the EM will be forfeited to the Government, and e-auction will be disposed of in the favor of second highest bidder.
- Loading and transportation cost should be borne by the bid winners. The undersigned will issue Transit Pass for the forest produces once auctioned amount is deposited.
- The sawn timber shall be for consumption within the State of Manipur only and no permit for transportation of the timber in log form outside the state shall be granted. The bidder shall apply for Transit Pass for the auctioned quantity before movement.
- The Divisional Forest Officer, Chandel Forest Division, Chandel reserves the rights not to accept or reject any tender/bid without assigning any reason thereof.
- Acceptance of the bid amount will be subject to the approval of the appropriate authority of the Forest Department, Manipur.
- In case of any dispute, the decision of the Principal Chief Conservator of Forests & HoFF, Government of Manipur shall be final and binding to all the parties.
