



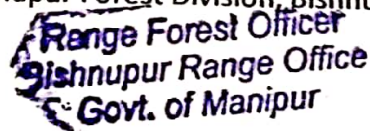
Terms and conditions of the Auction Sale of Timber *vide e-Auction Notice no. 6/11/2019/DFO-B*
dated 15th February, 2021

1. Any registered Forest Contractors/HPC cleared Sawmills located within approved MIEs/Wood based Units/Individuals may join the e-Auction sale.
2. The intending bidders may register at the Forest Department portal www.forest.manipurforest.gov.in for participating in the auction sale and bid till 5.00 pm of 26.02.2021.
3. The intending bidders may inspect the logs and get themselves satisfied of the quality and quantity of logs before joining the auction. No complaint on the quantity and quality of the logs after finalization of the auction sale shall be entertained. Details of lot(s) can be seen from the notice board.
4. The intending bidders shall deposit Earnest Money @ 5% of the value of the floor price of the timber as shown in Annexure-I, in the form of D-at-Call/Banker's cheque for the log(s) he/she intends to apply to be drawn in the favour of the Divisional Forest Officer, Bishnupur from any Scheduled Banks or in Cash to the O/o the DFO, Bishnupur for joining the e-Auction sale.
5. The Earnest Money deposited shall be refunded after the finalization of the auction sale or may be forfeited to the Government if the terms and conditions of the auction sale are violated.
6. Amount once bided cannot be withdrawn. In case of withdrawal, the Earnest Money deposited will be forfeited to the government.
7. The successful bidders shall deposit the bid amount along with taxes to the Division Office within 5 (five) days of approval of rate by the competent authority, failing which, the EM will be forfeited to the government.
8. The Divisional Forest Officer, Bishnupur Forest Division reserves the rights not to accept or reject any tender/bid without assigning any reason thereof.
9. Acceptance of the bid amount will be subject to the approval of the appropriate authority of the Forest Department, Manipur
10. In case of any disputes, the decision of the Conservator of Forests, Southern Circle, Government of Manipur shall be final and binding to all the parties.

In connection to Offence No. 75/2020 dated 11-2-2020 of the Office of the Range Forest Officer, Bishnupur Range, Manipur, whereas it has been found that 8 (eight) round logs of A2- Class and 1 (one) round log of C-Class timber as given in table below, have been recovered from the roadside of Bishnupur-Khoupum road near Ngarian on the 10th February, 2020. Any Forest produce as defined in Section 2(4)(a) of Indian Forest Act, 1927, when the question arises as to whether any forest-produce is the property of the Government, such forest produce shall be presumed to be the property of the Government until the contrary is proved u/s 69 of Indian Forest Act, 1927.

Notice is hereby served u/s 46 of Indian Forest Act, 1927, to the General Public that claims in written are invited of the same and may kindly contact the Office of the Divisional Forest Officer, Bishnupur Forest Division within a period not more than 2 months from the date of this notice, failing which it will be disposed of u/s 48 of the Indian Forest Act, 1927.
