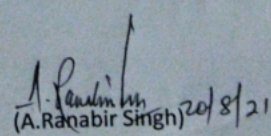

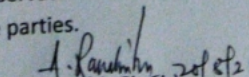

Terms and conditions of the e-auction sale of the confiscated sawn teak timber vide e-auction notice
no. No. 4/37/2020-21/TPL: dated 20th August, 2021

1. Any registered Forest Contractors/HPC cleared Saw Mill located within approved MIEs/Wood Based Units/Individuals may join the e-Auction sale.
2. The intending bidders may register at the Forest Department portal forest.manipurforest.gov.in for participating in the auction sale and bid till 5:00 pm of 28.08.2021.
3. Auction sale of the sawn teak timber will be done in 6 lots- (Annexure - I)
4. The intending bidders may inspect the sawn timber and get themselves satisfied with the quality and quantity of timber before joining the auction. No complaint on the quality and quantity of timber after finalization of the auction sale shall be entertained. Details of sawn timber can be seen from the Notice Board.
5. The intending bidder shall submit the duly filled in auction participation form (Annexed) along with the Earnest Money @ 5% of the value of the floor price of the Teak timber which is Rs. 1,120.00 per cu.ft. as fixed vide Order No. FOREST-101/14/2020-21-FE-Dept (For & envt.) dated 02.12.2020 of the Secretariat Forest & Environment Department, Manipur, if they are interested in the form of D-at-Call/Banker's cheque from any Scheduled Bank drawn in favour of Deputy Conservator of Forests, Tengenoupal Forest Division, Manipur or in Cash to the O/o Dy.CF/Tengenoupal for joining the e-auction sale for each Lot latest by 5:00 pm of 28.08.2021.
6. The Earnest Money Deposited shall be refunded after finalization of the auction sale or may be forfeited to the Government if the terms and condition of the auction sale are violated.
7. Amount once bided cannot be withdrawn. In case of withdrawal, the Earnest Money Deposited will be forfeited to the Government.
8. The successful bidders shall deposit the bid amount along with taxes to the Division Office within 5 (five) days of the approval of rate by the competent authority, failing which, the EM will be forfeited to the Government.
9. The timber shall be for consumption within the state of Manipur only and no permit for transportation of timber outside the state shall be permitted.
10. The Dy. Conservator of Forests, Tengenoupal Forest Division, Tengenoupal reserves the right not to accept or reject any tender/bid without assigning any reason thereof.
11. Acceptance of the bid amount will be subject to the approval of the appropriate authority of the Forest Department, Manipur.
12. In case of any dispute, the decision of the Conservator of Forests, Eastern Circle, Government of Manipur shall be final and binding to all the parties.
