E-Auction Notice

Kangpokpi, the 6th September, 2021

No.5/8/2017/DFO-Kpi/143 :- In accordance to powers conferred u/S 56 of IFA,1927 the following seized/confiscated forests produce in connection with POR/KPK/2021/7516, /7517, /7518, /7520,/7521,/7522, /7523, /7524, /7525, /7526, /7528, /7529 of 2020-2021 dated 14th July,2021, of Kangpokpi Range Office and Confiscation order No.6/22/2019/DFO-Kpi/141 of Office of the Divisional Forest Officer, Kangpokpi Forests Division, Government of Manipur, dated 3rd September,2021 in the court of the authorized officer, Kangpokpi Forests Division, which are government properties, it is hereby notified to all the registered Forest Contractors/HPC cleared Sawmills/WBUs in approved Industrial Estates/intending individuals that timber logs 66 (sixty six) nos. -49 nos. (forty nine) of Ucham (*Artocarpus chaplasha*), 8 nos. (eight) of Usoi (*Schima wallichii*), 5 nos. (five) of Pareng (*Alnus nepalensis*) and 4 nos. (four) of Heirikokthong (*Artocarpus lakoocha*) with volume of 1843.45 Cft (52.20 cum) lying in 12 (twelve) lots at Sawombung Forest Nursery Complex, under Sawombung, Central Forests Division, Imphal shall be sold by e-auction under the following terms and conditions. Abstract of the lots, Floor Price/Upset Price and Earnest Money deposit of the sawn timbers are enclosed in **Annexure-I**. Intending bidders may apply for the e-auction on the Forest Department's portal **forest.manipurforest.gov.in** from 6th September,2021 to 15th September, 2021 (10:00 PM). The e-auction shall be opened on 16th September ,2021 at 11:30 AM.

Terms and Conditions

1. Intending Registered Forest Contractors/ HPC cleared Sawmills/Wood based Units/Individuals may register and apply for the e-auction on the Forest Department's portal **forest.manipurforest.gov.in** from 6th September,2021 to 15th September, 2021 (10:00 PM). Bids after the due date shall not be accepted.
2. Intending bidders may inspect the timbers and get satisfied themselves of the quality and quantity of the timber before joining the e-auction. No complaint on the quality and quantity of the timber after the auction sale will be entertained.
3. The intending bidders shall deposit 5% of the floor price as Earnest Money deposit, as shown in **Annexure-I**, in the form of D-at-Call/Banker's cheque for the lots he intends to apply to be drawn in favour of the Divisional Forest Officer, Kangpokpi from any Scheduled Bank.
4. The rates should be offered for an entire Lot and no part of a lot can be bidden separately. A bidder can apply for all the lots, but separate bids should be offered for each lot.
5. The auction shall be opened and compiled by a Committee constituted by the Divisional Forests Officer/ Kangpokpi Forest Division and in presence of the bidders or his authorized person, if any, on 16th September ,2021 at 11:30 AM at Kangpokpi Forest Division Office, Kangpokpi, Manipur.
6. The timber shall be for consumption within the State of Manipur only. If the successful bidder intends to transport the timbers outside the State, but within the North-East, he shall obtain special permission from the State Government and pay outside TP fee and other charges as per the Rules.
7. The Earnest Money deposit will be refunded to all bidders after the finalization of the auction sale or shall be forfeited in case of violation of terms and conditions of the auction sale.
8. Auction once bidden cannot be withdrawn. In case of withdrawal, the Earnest Money deposit will be forfeited.
9. Successful bidders should deposit the bid amount along with applicable GST within 10 (Ten) days of the approval of rate/ bid value by the competent authority, failing which, the Earnest Money deposit will be forfeited to the Government and next highest bidder shall be considered.
10. The Divisional Forest Officer, Kangpokpi Forest Division reserves the rights not to accept or reject any bid without assigning any reason thereof.
