In view of the expressed difficulties faced by the Territorial Forest Divisions and some of the Wood Based Industries in accessing the online monitoring portal which has developed some technical snags since 1st April, 2022 and keeping in view the need to issue Transit Pass/ STP for the forest produces in transit, the directions given by this Office in the Office Memorandum of even No. dated 27.11.2020 may be followed. Accordingly, Territorial DFOs may utilize the manual Transit Pass (STP) under intimation to their respective Conservator of Forests with valid justification.

Similarly, concerned Territorial DFOs may judiciously issue 'Water Marked LTP' to WBIs for transportation of their respective finished veneer/plywood products outside the State. In doing so, it must be ensured that the quantity of finished veneer/plywood products for which TP is being issued, is well within the allocation made to that particular WBI(s).

Sub: Use of manual Transit Pass/ STP during urgency when the Online Portal for "Monitoring of Transit of Forest Produces, Revenue Collection and prevention of illegal transport and wildlife crimes" is under maintenance or facing technical snags-reg.

It has come to the notice of this office that the urgency to issue Transit Pass/ STP for the forest produce in transit especially the forest produce entering the boundary of the State of Manipur without valid documents has been faced by the Territorial Forest Divisions. During such circumstances, if the Online Portal for "Monitoring of Transit of Forest Produces, Revenue Collection and prevention of illegal transport and wildlife crimes" is under maintenance or facing technical snags, then the Divisional Forest Officer may utilize the manual Transit Pass/STP under intimation to their respective concerned Conservator of Forests with valid justification if he/she is satisfied that the Transit Pass needs to be issued immediately, on a case to case basis.
