**Terms and conditions of the e-auction sale of 15(fifteen) nos. Pine logs (A-2 Class) collected from Tharoisibi Lok, Chingkheiching RF containing 2.89 cum i.e. 102.06 cft vide e-auction notice no. 6/8/2016-17/DFO/C(Auction) dated 6/06/2022**

1. Any registered Forest Contractors/ HPC cleared Saw Mill located within approved MIEs/Wood Based Units/ Individuals may join the e-auction sale.
2. The intending bidders may register at the Forest Department portal **forest.manipurforest.gov.in** for participating in the auction sale bid till 11 pm of 12/06/2022.
3. The Intending bidders may inspect the wind blown Pine trees as is where is basis and get themselves satisfied of the quality and quantity of 30(thirty) nos. Pine trees (A-2 Class) collected from Langol RF containing 14.85 cum i.e. 519.75 cft dumped at Langol RF before joining the auction sale. No complaint on the quality and quantity of the logs after finalization of the auction sale shall be entertained. Details of logs can be seen from the notice board.
4. The intending bidders shall deposit Earnest money @ 5% of the value of the floor price of 30(thirty) nos. Pine trees (A-2 Class) collected from Langol RF containing 14.85 cum i.e. 519.75 cft dumped at Langol RF they are interested top bid in the form of D-at-Call/Banker's Cheque from any scheduled bank drawn in favour of DFO/Central Forest Division, Manipur or by depositing in cash to the O/o DFO, Central (if the above facilities are unavailable due COVID) for joining the e-auction sale.
5. The earnest money deposited shall be refunded after finalization of the auction sale or may be forfeited to the Government if the terms and conditions of the auction sale are violated.
6. Amount once bided cannot be withdrawn. In case of withdrawal, the earnest money deposited will be forfeited to the Government.
7. Successful bidder should deposit the bid amount along with GST @ 18% of the bid amount to the Division Office within 3 (three) days of the approval, failing which, the earnest money deposited will be forfeited to the Government and the e-auction will be disposed off in favour of the next 2<sup>nd</sup> higher bidder.
8. The timber shall be for consumption within the state of Manipur only and no permit for transportation of log form outside shall be granted.
9. The successful bidder shall deposit the bid amount along with taxes to the Division Office within 5 (five) days of the approval of rate by the competent authority, felling which, the EM will be forfeited to the Government.
10. The Division Forest Officer, Central Forest Division, Imphal reserves the rights not to accept or reject any tender/bid without assigning any reason thereof.
11. Acceptance of the bid amount will be subject to the approval of the appropriate authority of the Forest Department, Manipur.
12. In case of any dispute, the decision of the Conservator of Forests, Central Circle, Government of Manipur shall be final and binding to all the parties.
