

Terms and conditions of the e-auction sale of the confiscated Khangra/Yangou logs vide auction notice no. 4/37/2020-21/TPL dated 3<sup>rd</sup> August, 2022

1. Any registered Forest Contractors/HPC cleared Saw Mill located within approved MIEs/Wood based Units/Individuals may join the e-Auction sale.
2. The intending bidders may register at the Forest Department portal [forest.manipurforest.gov.in](http://forest.manipurforest.gov.in) for participating in the auction sale and bid till 5.00 pm of 10.08.2022.
3. Auction sale of the sawn teak timber will be done in 8 lots, i.e., (i) Lot-1 (315.92 cft) (ii) Lot-2 (333.96 cft) (iii) Lot-3 (312.14 cft) (iv) Lot-4 (342.51 cft) (v) Lot-5 (335.87 cft).
4. The intending bidders may inspect the Khangra/Yangou logs and get themselves satisfied of the quality and quantity of timber before joining the auction. No complaint on the quality and quantity of the logs after finalization of the auction sale shall be entertained. Details of Khangra/Yangou logs can be seen from the notice board.
5. The intending bidders shall submit the duly filled in auction participation form (Annexed) along with the Earnest Money @ 5% of the value of the floor price of the Khangra/Yangou logs (A1) which is Rs. 450.00 per cu.ft. as fixed with the Concurrence of Finance Department vide their U.O. No. 3/2022-23/FD(19-P/3), dated 02.06.2022, by the Secretariat Forest & Environment Department, Manipur, dated 16<sup>th</sup> June, 2022 if they are interested to bid in the form of D-at-Call/Banker's cheque from any Scheduled Bank drawn in favour of Deputy Conservator of Forests, Tengnoupal Forest Division, Manipur or in Cash to the O/o. Dy.CF/Tengnoupal for joining the e-auction sale for each lot latest by 5:00 pm of 10.08.2022.
6. The Earnest Money deposited shall be refunded after finalization of the auction sale or may be forfeited to the Government if the terms and conditions of the auction sale are violated.
7. Amount once bided cannot be withdrawn. In case of withdrawal, the Earnest Money Deposited will be forfeited to the government.
8. The successful bidders shall deposit the bid amount along with taxes to the Division Office within 5 (five) days of the approval of rate by the competent authority, failing which, the EM will be forfeited to the government.
9. The timber shall be for consumption within the state of Manipur only and no permit for transportation of timber outside the state shall be permitted.
10. The timber, thus awarded should not be sawn at any other Sawmills other than licenced and HPC approved Sawmills.
11. The Dy. Conservator of Forests, Tengnoupal Forest Division, Tengnoupal reserves the rights not to accept or reject any tender/bid without assigning any reason thereof.
12. Acceptance of the bid amount will be subject to the approval of the appropriate authority of the Forest Department, Manipur
13. In case of any dispute, the decision of the Conservator of Forests, Eastern Circle, Government of Manipur shall be final and binding to all the parties.
