Terms and conditions of the e-auction sale of 19 (nineteen) nos. of Pine logs (A-2 Class) laying in the forest floor of Langol extension RF area of Loitang containing 1.78 cum i.e. 62.86 cft vide e-auction notice no. 6/8/2016-17/DFO/C(Auction) dated 17/08/2022:

- 1. Any registered Forest Contractors/ HPC cleared Saw Mill located within approved MIEs/Wood Based Units/ Individuals may join the e-auction sale.
- 2. The intending bidders may register at the Forest Department portal forest.manipurforest.gov.in for participating in the auction sale bid till 11 pm of 25/08/2022.
- 3. The Intending bidders may inspect the Pine logs as is where is basis and get themselves satisfied of the quality and quantity of 19 (nineteen) nos. Pine logs (A-2 Class) laying in the forest floor of Langol extension RF containing 1.78 cum i.e. 62.86 cft dumped at Langol Extension RF before joining the auction sale. No complaint on the quality and quantity of the logs after finalization of the auction sale shall be entertained. Details of logs can be seen from the notice board.
- 4. The intending bidders shall deposit Earnest money @ 5% of the value of the floor price of 19(nineteen) nos.
