Terms and conditions of the Re-e-auction care of the 87 cu.m of Khangra Logs vide auction Notice No. 19/1/AFP/2020-21/CDL dated 20/03/2024.

- Only registered Forest Contractors/HPC cleared Saw Mills located within approved MIEs/ Wood based Units/may participate the Re e-auction sale.
- 2. The intending bidders may register at the Forest Department portal forest manipurforest gov.in for participating in the e-auction sale and bid till 5.00 pm of 29th February 2024.
- 3. The intending bidders may inspect the Khangra logs and get themselves satisfied of the quality and quantity of the logs before joining the e-auction. No complain on the quality and quantity of the logs after finalization of the e-auction sale shall be entertained. Details of logs can be seen and verified for self satisfaction in the field/spots.
- 4. Intending bidders should submit an application for participating in the bid and should be accompanied by latest GST cleared documents and proof of legitimacy of the firm. The last date of submission of the above is 11.00 am of 29th February 2024 after which further applications will not be accepted. Finalisation of intending bidders will be at 03.00 pm of the same day.
- 5. The intending bidders shall deposit Earnest Money @ 10% of the value of the floor price of the Khangra timbers which is Rs. 266/- per cu.ft. for round logs in hill areas as fixed vide the letter dated 22/09/2022 of the Secretariat, Forest & Environment Department, Manipur. The interested bidders should deposit the amount in the form of D-at-Call/Banker's Cheque/ from any Scheduled Bank drawn in favour of DFO/Chandel Forest Division, Manipur or in Cash to the O/o Divisional Forest Officer, Chandel for joining/participating the e-auction sale.
- The Earnest Money deposited shall be refunded after finalization of the auction sale or may be forfeited to the Government if the terms and conditions of the auction sale are violated.
- 7. Amount once bid cannot be withdrawn back. In case of withdrawal, the Earnest Money Deposited will be forfeited to the government.
- 7. The successful bidder shall deposit the bid amount along with admissible taxes including the GST etc. to the Forest Division Office/ Chandel within 5 (five) days of the approval of the bid amount by the competent authority, failing which, the Earnest Money will be forfeited to the Government.
- 8. The Divisional Forest Officer, Chandel Forest Division, Chandel reserves the rights not to accept or reject any tender/bid without assigning any reason thereof.
- Acceptance of the bid amount will be subject to the approval of the appropriate competent authority of the Forest Department, Manipur.
- In case of any dispute, the decision of the Chief Conservator of Forests, T-II, GovernmentofManipur shall be final and binding to all the parties.
