- 4. The timber, thus awarded should not be sawn at any other Sawmill other than licensed and HPC approved Sawmills. The Bidder shall opt for all lots, bidding for select lots not permitted.
- 5. Only online bidding is allowed via https://forest.manipurforest.gov.in/tenders but in case website malfunctions offline bids will be accepted. No more advertisement will be made on this auction in Newspapers.

6. Successful bidder should deposit the bid amount along with 18% GST to the Division Office within 3 days of the final approval, failing which the earnest money deposited will be forfeited to the Government and e-auction will be disposed of in favour of the second highest bidder.

- 8. The timber shall be for consumption within the State of Manipur only and no permit for transportation of the timber in log form, outside the state shall be granted. The bidder shall apply for Transit Pass for the auctioned quantity before movement.
