**Terms and conditions of the auction sale of Round Timber vide auction notice  
no 19/01/AFP/2020-21/CDL, dated 06/06/2024**

1. Any registered Forest Contractors/HPC cleared Saw Mill located within approved MIEs/Wood based Units/Individuals may join the e-auction sale.
2. The intending bidders may register at the Forest Department portal forest.manipurforest.gov.in for participating in the auction sale and bid till 11:00 AM of 11 June, 2024.
3. The intending bidders may inspect the logs and get themselves satisfied of the quality and quantity of logs before joining the auction. No complaint on the quality and quantity of the logs after finalization of the auction sale shall be entertained. Details of logs can be seen from the notice board.
4. The intending bidders shall submit the duly filled in auction participation form (Annexed) along with the Earnest Money @5% of the value of the floor price of the **Khangra/Leihao round logs (A1 class-others) which is Rs. 450.00 per cft.** as fixed with the concurrence of Finance Department vide their U.O. No. 3/2022-23/FD(19-P/3), dated 02.06.2022, by the Secretariat Forest & Environment Department, Manipur, dated 16<sup>th</sup> June, 2022 if they are interested to bid in the form of D-at-Call/Banker's cheque from any Schedule Bank drawn in favour of Deputy Conservator of Forests, Chandel Forest Division, Manipur or in Cash to the O/o. DFO/Chandel for joining the e-auction sale for each lot.
5. The Earnest Money deposited shall be refunded after finalization of the auction sale or may be forfeited to the Government if the terms and conditions of the auction sale are violated.
6. Amount once bided cannot be withdrawn. In case of withdrawal, the Earnest Money Deposited will be forfeited to the government.
7. The timber shall be for consumption within the State of Manipur only and no permit for transportation of the timber in logs or sawn form outside the State shall be granted.
8. The successful bidders shall deposit the bid amount along with taxes to the Division Office within 5 (five) days of the approval of rate by the competent authority, failing which, the EM will be forfeited to the Government.
9. The Divisional Forest Officer, Chandel Forest Division, Chandel reserves the rights not to accept or reject and tender/bid without assigning any reason thereof.
10. Acceptance of the bid amount will be subject to the approval of the appropriate authority of the Forest Department, Manipur.
11. In case of any dispute, the decision of the Conservator of Forest, Central Circle, Government of Manipur shall be final and binding to all the parties.
