Terms and Conditions of the Auction Sale:

1. Any individual, registered Forest Contractor or registered firm may participate in the e-auction sale.
2. Intending bidders may register themselves at the Forest Department's portal [forest.manipurforest.gov.in](http://forest.manipurforest.gov.in) for participating in the e-auction sale and bid during the given date and time.
3. Intending bidders may inspect the firewood and bamboo lying at the office premises of Range Forest Officer/ Singngat and satisfy themselves of the quality and quantity of the firewood. No complain on the quality and quantity shall be entertained thereafter. Details of logs can be seen from the Notice Board of the undersigned.
4. Intending bidders shall deposit Earnest Money @ 5% of the value of the floor price of the Lot they are interested to bid in the form of D-at -call/ Banker's cheque from any Scheduled Bank drawn in the favour of the Divisional Forest Officer, Churachandpur Forest Division, Manipur or in Cash to the Office of the Divisional Forest Officer, Churachandpur on or before 3<sup>rd</sup> July, 2024 in order to participate in the e-auction sale.
5. The earnest Money deposited shall be refunded after finalisation of the auction sale or shall be forfeited to the Government if the terms and conditions of the auction sale is/are violated.
6. Amount once bided cannot be withdrawn. In case of withdrawal, the earnest money deposited shall be forfeited to the Government.
7. The firewood and bamboo shall be for consumption within the State of Manipur only and no permit for transportation outside the State shall be granted.
8. Successful bidders shall deposit the bid amount along with GST (wherever applicable) to the Divisional Forest Officer: Churachandpur Forest Division, Churachandpur within 5 days of receiving of intimation of acceptance of the bid amount.
9. Transportation of the sold firewood & bamboo will be the responsibility of the buyer and shall be permitted within the state of Manipur.
10. The DFO/ Churachandpur Forest Division reserves the right to accept or reject any bid without assigning any reason.
11. Acceptance of bid-amount will be subjected to the approval of competent authority of the Forest Department, Government of Manipur.
12. In case of any dispute, the decision of the Conservator of Forest, Southern Forest Circle shall be final and binding.
