



1. The Forest produces will be sold on as-is-where-is basis. Interested individuals/parties can check the quality and quantity during office hours. No complaints will be entertained once Bid is awarded after the cut-off date.
2. Interested bidders shall deposit the mentioned Floor price as EMD for e-auction sale (in form of DD/Cheque/cash, payable to Divisional Forest Officer, Bishnupur Forest Division), which will be adjusted in case of winning bid and refunded, if lost.
3. Only online bidding is allowed via <https://forest.manipurforest.gov.in/tenders> and no other means of bidding be allowed. No other advertisement will be made on this auction in Newspapers.
4. Successful bidder shall deposit the bid amount along with GST to the Office of the Divisional Forest Officer, Bishnupur Forest Division within 7(seven) days of the final approval, failing which the earnest money deposited will be forfeited to the Government and e-auction will be disposed off in favour of the second highest bidder.
5. Loading and transportation cost shall be borne by the bid winners.
6. The Divisional Forest Officer, Bishnupur Forest Division, Bishnupur reserves the rights not to accept or reject any tender/bid without assigning any reason thereof.
7. Acceptance of the bid amount will be subjected to the approval of the appropriate authority of the Forest Department, Manipur.
8. In case of any dispute, the decision of the Conservator of Forests, Sothorn Forest Circle, Government of Manipur shall be final and binding to all the parties.
