AUCTION NOTICE

Ukhrul, the 16th February, 2026

No.7/FCA/10/2023/LAYNE-JESS: In accordance to the "In-Principle Approval" granted under Section 2 (1) (ii) of the Van (Sanrakshan Evar Samvardhan) Adhiniyam, 1980 vide letter No: FP/MN/ROAD/450638/2023/2147-49 dated 16th October, 2024 from IRO, Shillong for the Proposed Diversion of 26.424 Ha of Forest Land for Widening and Improvement for 2 (two) lane with Earthen Shoulders of Jessami to Lanye Bridge (Nagaland Border) Section of NII 29 from existing chainage Km 138.386 to Km 149.415 (Proposed chainage From Km 0.00 km to km 11.009) in the State of Manipur on EPC Mode by NIIDCL, the felled trees for the extension of the road amounting to 77.5 CUM (2736.75 Cft) i.e., 7 LOGS of A1-Class 14.45 Cum (510.14 Cft); 30 LOGS of A2 Class-33.58 Cum (1185.95 Cft); 8 LOGS of B- Class 8.68 Cum (306.53 Cft), 13 Logs of 20.79 Cum (734.12 Cft) of C-class shall be sold by way of e-auction through Forest Department's online portal www.forest.manipurforest.gov.in and bidding can be done till 28th February, 2025.

TERMS AND CONDITIONS

1. Intending Registered Forest Contractors/HPC Cleared Sawmill/Wood based Units/ individuals may register and apply for the e-auction on the Forest Department's Portal www.forest.manipurforest.gov.in from 17th February, 2026 to 28th February, 2026 (6:00 pm). Bids after the due date shall not be accepted.
2. Intending bidders may inspect the timbers and get satisfied themselves of the quality and quantity of the timber before joining the e-auction. No complaint on the quality and quantity of the timber after the auction sale will be entertained.
3. The intending bidders shall deposit 5% of the floor price as Earnest Money Deposit in D-at-Call for auction sale in the form of DD/Banker's cheque for the lots he intends to apply to be drawn in favour of the Divisional Forest Officer, Ukhrul Forest Division from any Scheduled Bank
4. The rates should be offered for an entire Lot and no part of a lot can be bid separately. A Bidder can apply for all the lots, but separate bids should be offers for each lot.
5. The auction shall be opened and compiled by a Committee constituted by the Divisional Forests Officer/ Ukhrul Forest Division and in presence of the bidders or his authorized person, if any, on 2nd March, 2026 at 11:30 am at Ukhrul Forest Division Office, Ukhrul, Manipur.
6. The timber shall be for consumption within the States of Manipur only. If the successful bidder intends to transport the timbers outside the State, but within the North-East, he shall obtain special permission from the State Government and pay outside TP fee and other charges as per the Rules.
7. The Earnest Money Deposit will be refunded to all bidders after the finalization of the auction sale or shall be forfeited in case of violation of terms and conditions of the auction sale.
8. Auction once bided cannot be withdrawn. In case of withdrawal, the Earnest Money Deposit will be forfeited.
9. Successful bidders should deposit the bid amount along with applicable GST within 10 (Ten) days of the approval of rate/bid value by the competent authority, failing which, the Earnest Money Deposit will be forfeited to the Government and next highest bidder shall be considered.
