No.7/FCA/13/2024/KUI-HUI-POI: In accordance to the “In-Principle Approval” granted under Section 2 (1)(ii) of the Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980 vide letter No: FP/MN/DEF/506071/2024 dated 18th February, 2025 from IRO, Shillong for Construction/Improvement of road Kuirei-Huishu-Poi (Section-B Km 16.325 to Km 34.650) to NHSL specifications under 84 RCC/25 BRTF Project Sewak in the State of Manipur, the felled fuel-wood for the extension of the road shall be sold by way of e-auction through Forest Department’s online portal www.forest.manipurforest.gov.in and bidding can be done till 12th March, 2026.

TERMS AND CONDITIONS :

1. Intending JFMCs/Registered Forest Contractors/HPC Cleared Sawmill/Wood based Units/ individuals may registered and apply for the e-auction on the Forest Department’s Portal www.forest.manipurforest.gov.in from 5th March, 2026 to 12th March, 2026 (6.00 pm). Bids after the due date shall not be accepted.
2. Intending bidders may inspect the firewood and get satisfied themselves of the quality and quantity of the timber before joining the e-auction. No complaint on the quality and quantity of the firewood after the auction sale will be entertained.
3. The intending bidders shall deposit 5% of the floor price as Earnest Money Deposit in D-at-Call for auction sale in the form of DD/Banker’s cheque for the lots he intends to

apply to be drawn in favour of the Divisional Forest Officer, Ukhrul Forest Division from any Scheduled Bank.

4. The rates should be offered for an entire Lot and no part of a lot can be bid separately. A bidder can apply for all the lots, but separate bids should be offer for each lot.
5. The auction shall be opened and compiled by a Committee constituted by the Divisional Forests Officer/ Ukhrul Forest Division and in presence of the bidders or his authorized person, if any, on 13th March, 2026 at 11:30 am at Ukhrul Forest Division Office, Ukhrul, Manipur.
6. The Earnest Money Deposit will be refunded to all bidders after the finalization of the auction sale or shall be forfeited in case of violation of terms and conditions of the auction sale.
7. Auction once bided cannot be withdrawn. In case of withdrawal, the Earnest Money Deposit will be forfeited.
8. Successful bidders should deposit the bid amount within 10(Ten) days of the approval of rate/bid value by the competent authority, failing which, the Earnest Money Deposit will be forfeited to the Government and next highest bidder shall be considered.
9. The Divisional Forest Officer, Ukhrul Forest Division reserves the rights not to accept or reject any bid without assigning any reason thereof.
10. Should any dispute arise, the decision of the Principal Chief Conservator of Forests & HoFF, Manipur shall be final and binding to all the parties.
